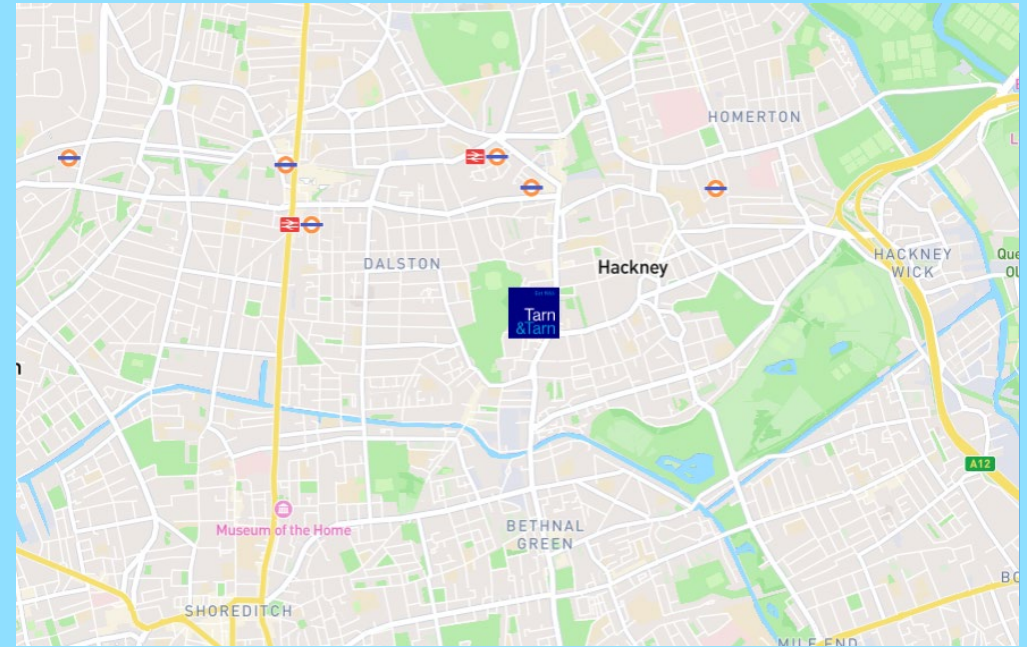
LOCATION
